The color of the year for 2019 is Living Coral. Just about as spring like as you can get. So, if you want to be current, put this color on your pallet, and you will be considered "trendy"! By the way last year's color of the year was, **Ultra Violet**. Enjoy the spring, in whatever colors you are painting.

What's the story on Cadmium in our paints?

If you recently read some popular art magazines, you may have seen large eye-catching advertisements from artist paint manufacturers claiming "our paints are now Cadmium Free "! How did the cadmium "alert" come about, and should we artists be concerned that this substance, which has been found in the pigment making process since the impressionist period, will increase our health risks? It all started with a study in Sweden submitted to the European Chemical Agency, (like our DEP), claiming that cadmium, a heavy metal, is spreading over agricultural land via sewage sludge. It suggested that some of this contamination is a result of artists rinsing their brushes in the sink. Therefore, the toxic substance could be polluting the food chain and increasing the risk of cancer and skeletal fracture due to the substance's dramatic negative effect on calcium levels in the bones, (among other diseases). Cadmium is one of the main components used to create bright intense pigments in red, yellow, and brown hues. It was discovered around 1820 and commercialized for artists use in the mid 1840's. Monet's famous yellows contained cadmium pigment.

In comparison, Lithium-ion batteries, which contain highly concentrated levels of cadmium, are a real problem and their lack of regulated proper disposal greatly contributes to much more danger of the pollutant than washing your brush in the sink. It was an easy fix for the ECA to ban everything with cadmium in it, however, not satisfied with the suggestion to ban the small amount of cadmium in artist's paint pigments, a paint manufacturer in the UK took up the cause to prevent the ban. They enlisted famous artists and art historians worldwide to join the cause to convince the European Chemical Agency that pigments such as cadmium are indispensable to artists, perfectly safe, and are critical in producing strong lightfast unique shades. When compared to other cadmium laced products, (batteries for instance), the levels of 0.1 % contained in artists paints are low enough to be considered safe. The ECA has reconsidered their ban and we can continue to buy paints to duplicate Monet's yellows without fear of risking our health. However, if you are still skeptical, you can buy cadmium free acrylic, oil, and watercolor paints in the retail market.

MRGA ART CRITIQUE ...5/3/2019 GERI THOMAS – BIOGRAPHY

Geri Thomas was President of Thomas & Associates, Inc., an innovative firm that offered staffing, consulting and professional development programs for museums, galleries, and art businesses nationally and internationally. The company closed in September 2017 after 18 remarkable years of service.

She has been involved with recruitment and executive search, organizational development, and consulting for such organizations as The Metropolitan Museum of Art; Christie's, Artnet.com; The Newark Museum; Galerie Lelong; Marlborough Gallery; Pace; Sean Kelly Gallery; Phillips; the Corning Museum of Glass, The Rockwell Museum of Western Art, The DuSable Museum, the Hudson River Museum, and the Studio Museum in Harlem.

Before starting her own company, Geri was Director of Exhibitions and Collections at the Jewish Museum in New York. Previous to that, she lived in New Zealand where she was on the initial planning team for the new national museum, Te Papa. She has been an interim director twice in her career, first at the Jersey City Museum, and at Lyndhurst, a museum and historic site of the National Trust for Historic Preservation.

She has lectured widely and presented numerous papers on professional development and recruitment in the United States and internationally including: a presentation on leadership, management and staff development at the Victoria and Albert Museum in London; the status of the arts & culture workplace in the United States at the ICOM Annual Meeting in Seoul, Korea; Sense of Urgency: the Need for Training and Career Paths in US Museums at the ICOM Annual Meeting in Vienna, Austria; and, Professional Development: The Best New Old Thing at the Irish Museum Association in Kilkenn ,Ireland. She has been a panelist and grant reviewer for the National Endowment for the Arts and for the DC Commission on the Arts and Humanities in Washington, D.C.

As an Associate Member of the Appraisers Association of America, she completed the Comprehensive Appraisal Studies Program in 2017 and is USPAP compliant (Uniform Standards of Professional Appraisal Practice). Geri is an Associate Professor at NYU where she teaches Museum Management and Fundraising for the Arts. With NYU, she developed a new Certificate Program in Art Collections Management, Registration and Display in 2011. At Christie's Education she has taught a professional development component for the MA Program in Art, Law and Business. She is a Leadership Circle member of ArtTable, the prestigious group of professional women in the arts, and organized their popular Breakfast at Christie's events in Chicago.

April Meeting


Our April Members' Meeting had a demonstration by Carol Colvin on her collage technique.
